Good news on the *Metropolitan report : economic indicators for the New Orleans area / Division of Business and Economic Research, University of New Orleans*. as reported to us by the editor. EL 520.7/2: date.

"Our policy was to delay shipping the current Metropolitan Reports to encourage folks to buy the publication instead of using library copies. After reviewing our subscriber list, we determined that we could share the current issues of the Metro Report with state [depository] libraries as requested. Our initial intention was to build up our subscriber list enough to help cover the cost of producing this publication. We are happy to begin mailing current issues, starting with January 2005, which is currently at the printer [Feb. 2005].

We have experienced delays in publishing due to numerous reasons. The main reason was due to our editor's retirement which also coincided with the SIC to NAIC conversion. At this time (to complicate things) we briefly interrupted production of the Metro Report (see the specifics below). However, I am happy to report that we are back on track and have resumed printing. Our plans are to (hopefully) release all future issues on a timely basis.

It is important to note that there will be a change in the volume/number for the April 2005 issue. The April 2005 issue will be Volume 16, No. 5. This will be the one and only no. 5 issue ever published. The volume and numbering system got jumbled when the printing was halted and resumed, see below.
