If you file Legislative Auditor reports by LaDoc number, contact me for the changes for audits of the mental health systems, facilities and hospitals. Hospitals have been moved to Y 9.2: MHxx/date where xx is the city. Systems are now Y 9.2: MHSxx/date where xx is the city.

LaDoc number EL 700.7/2:date used for Pilot's Log from Alumni Office, 1982-1995, then began use for LSUS News. *LSUS News* began 1997 with v. 31 based on the last volume number of its predecessor. It superseded Under the Arches, which probably ceased in 1971, and some earlier newsletters for faculty/staff and *Pilot's Log* for alumni. *LSUS News* went to everyone: faculty, staff, alumni, supporters and community. LSUS Archives has copies of most issues of these titles.

We try to get the full complement of copies of items submitted to the depository program. We often hold a single issue or incomplete submission while we ask the agency/institution for more copies. Sometimes it works, sometimes it doesn't. If the document is one they make money from, it is difficult to convince the agency/institution to send 'free' copies, even though the law requires it. We do try to negotiate to at least get 3 copies so the historical depositories each have a copy to archive. After waiting a couple of months, we give up and distribute what we have. An example this month is the *Louisiana Education Research Journal*; they only send 1 copy. I just wanted you to know we are trying. Another example is three literary pubs from Nicholls; we got current issues this month and have requests back issues: *Mosaic*, *Jubilee Anthology*, *La. English Journal*.

One final (I hope) try to straighten out LaDoc numbers for some The Board of Elementary & Secondary Education annual reports. BESE publishes a traditional *Annual Report*, **E 2.1: date**. There are 4 publications about the minimum foundation program which were moved from E 2.1: date to some variation of E 2.1: MFP in late 2003.

There are two 8(g) reports each year. Titles have varied ~~some~~ lots. They usually have "Louisiana Education Quality Trust Fund" on the cover. The BESE staff has assured us that, in the future, they will try to maintain consistent titles from year to year and, within publications, from cover to title page.

1. One is the Report to the Committee on Education [legislature] which is the Annual 8(g) Program and Budget. It contains the *proposed budget/spending and activities* for the fiscal year. It started out as E 2.1: date for 1989/90 – 1994/95. It became **E 2.1: AR/date** and remains that.

2. The 8(g) Annual Report has had various titles and subtitles using Program Results (2000/01 - ), Annual Evaluation Report (1995/96, E 2.1: ER/date), Program Evaluation Report and similar wording. The 1994/95 report was split into 2 volumes with titles using "Locally Implemented Projects" (E 2.1: LIP/date). All of these discuss *what actually happened* – what activities were accomplished and how the funds were utilized during the fiscal year. This report began with E 2.1: date and was later reassigned E 2.1: AR/date. To distinguish this results report from plan report, I am changed the LaDoc number to **E 2.1: RPR/date**.

If you have read this far, please know that I appreciate the time and effort involved in reclassifying documents and I apologize for changing some of these numbers yet again. Some of the confusion built up over years of various recorders, some I unwittingly created myself. Please continue to contact me about duplicate numbering and classification problems.
