9/15/05: "The Ayo Years, 1983-2003," a follow-up book to "[Nicholls State University:] The Elkins-Galliano Years," [1999] will be on sale for the first time Sept. 16, in the lobby of the Student Union. The 599-page book includes 45 photographs. The appendix is actually a 57-year Nicholls almanac. The book sells for \$29.95 (cash, or checks payable to Kappa Tau Alpha), and every penny of sales income will go toward scholarships. The book was published by the Nicholls State University Foundation, and printing costs were underwritten by the Lorio Foundation of Thibodaux. The book consists of 16 chapters, each carefully footnoted. Sales will continue from the Department of Mass Communication. Wal-mart and Hofman Music of Thibodaux began selling the books today as a community service and will sell them indefinitely. The books will not be in for-profit bookstores until October.
