1/25/07 Claudia Evans, University Relations, ULMonroe (our hero for straightening all these titles out) compiled this info [EL 100.7: v/#/yr]. I have tried to correct the notes in the State Library catalog records.

The first publication, Alumni News, started in 1953. In 1982 it was renamed Drumbeat. From 1953 until 2002, the Alumni News and then Drumbeat [sometimes Indian Drumbeat]. were published in a newspaper/newsletter format.

Impact [EL 100.7/4:] was published Fall/Winter 1998 through Winter 2002 (6 issues in all). In content and magazine format it was like the ULM magazine, "the university magazine" but did feature prominent alumni and was distributed to major donors of the university. During this time, Drumbeat was still published in the newspaper/newsletter format.

Impact final issue was Winter 2002. At that time the University stopped producing Drumbeat in the newspaper/newsletter format and went to magazine format keeping the name Drumbeat. Now in magazine format, Drumbeat was last printed under the name Drumbeat in Spring 2005.

In Fall 2006, the Drumbeat name was changed to "ULM Magazine." It is mailed to dues paying alumni and major donors. Volume numbering continues Drumbeat as v. 7, no. 1

After some justified lobbying, I changed the designation of the CRT departmental newsletter to 'not a state doc.' It is sent to CRT employees via email and is available only on the CRT intranet. We had always printed out 1 copy that went to the State Library. It was called From the Secretary and some other titles. The record has been removed from the SLL catalog. Cu 1.7/2: date.

1/16/07, we received a letter from the Judiciary Commission of La Counsel letting us know that the Commission is not a state agency under the Depository Program definition and, in any case, than its documents are confidential. We will not be receiving minutes or any other docs from the Commission and we are removing it from our master list of boards/commissions. This is different from the Judicial Commission. We did receive The Judiciary Commission of La 1968-1978, Judiciary Commission, 1979, 18 p., in 1979.

The Greater Lafourche Port Commission submitted several items this month with identical or very similar titles e.g. Port Fourchon. We have tried to differentiate new
