In this Feb. shipment is the package of documents that the La. delegation took to Washington D.C. when they **testified before Congress** in 2005. The depository program received and distributed the full number of copies (31) to those libraries that selected Governor's Office.

3/2006 Tim at **La Housing Finance Agency** (LHFA), 763-8800 x268, gave me the following information: There are 3 groups of materials which are presented/published once or twice a year:

- (1) Performance based contract administration owner/agent guide.
- (2) LAHMA presentation [LHFA presentation to La Housing Management Assn.
- (3) Section 8 contract administration, LHFA meeting.

La Housing Finance Agency considers these 3 to be basically a single documents with the title: Performance based contract administration owner/agent guide. T 5.5: OAG/date. This is distributed to 15 depositories who selected to receive Treasury Dept. docs and did not exclude agency publications.

Each of the 3 groups usually have all of the cover/title sheets somewhere in the pages of a group but the same cover/title page is not always on top/first.

The 3 groups have much the same info but are arranged in various ways from date to date (presentation to presentation). The group with most current date will have most current info but may not have exactly the same info as the earlier groups. Most libraries can probably get by with only the most current date but historical libs will need to keep them all. However, this title is not on the current Superseded List.

The Feb. 2006 shipment includes 4 items. The cover/top pages are:

- (1) Performance based contract administration owner/agent guide, 816/05. Earlier, we distributed 3/21/03 final version and 6/2004 rev.
- (2) Section 8 contract Administration, LHFA Meeting, 2/18/05; 9/30/04 is a dup, originally distributed 10/04. {former LaDoc T 5.6: Sec8/Sept 2004}
- (3)) LAHMA presentation. 7/21/04. {1st time we got an item with this as cover/top page}

All 4 of these items now have LaDoc T 5.5: OAG/date to group them together. You may want to pass all this info along to your cataloger. It may save them some time and frustration, even if they do not agree with how I decided to handle these items.

In February and March, we are continuing to distribute all the **board/commission minutes** we receive. In the March shipment, you will receive a survey to complete about the minutes. Your responses will be presented at the May 12 Advisory Council meeting during a discussion about the depository libraries' needs for these minutes.

I suggest you do not process the minutes you receive in Jan, Feb & March until after a decision is agreed on in May about the number of copies. The decision will include what to do about previous issues if we limit distribution to only 3 copies. Please contact Ferol if you need clarification.
