2006 Roster of officials of the state of Louisiana is distributed this month. I am again recommending you continue to **keep the 2002 edition**. The 2004 and 2006 editions section of boards and commissions list only address, phone and enabling legislation. It does not list oversight agency, names of officers or members, or web address. The agency data is in the Auditor's report: Boards, Commissions, and Like Entities, <http://www.la.state.la.us/bdcomm.pdf>. Names of officers and members are in the Senate Louisiana Boards and Commissions Database, <http://www.legis.state.la.us/boards/boardsearch.asp>

Beginning about 2004, the State Library began cataloging as monographs all legislative audit reports that were not the regular financial audit. Before that, when the title was the same, we had included procedural audits and other types in the main audit record. Well, we are going back to the earlier practice of including various types of audits on the main financial audit record... at least for as long as we can get away with it.

At repeat from March MSL: Board/commission minutes [the big confusion caused by me continues]

We sent semi-annual letters to many boards and commissions in Nov. 2004. Those that responded usually supplied the full number of copies of the minutes. It turned out to be LOTS of minutes even though we have not gotten minutes from all of the 260+ boards and commissions; some meet monthly.

The law says the Recorder of Documents can 'adjust' the number of copies required so in late Jan., I decided to only distribute 3 copies for some of the boards/commissions. The 3 copies were distributed to State Library, LSU-BR and La Tech, the historical depositories, to file/archive.

On Feb 7, I had 2nd thoughts so I polled several depositories that selected to get minutes from agencies, especially port/levee boards. I heard back from 4 of the 7: two law libraries wanted ports/levees and some others; 1 public library did not want any; 1 academic library could live without minutes but would like BESE minutes online [BESE only submits 2 or 3 copies and does not put their minutes online].

We distributing all copies we receive in Feb. and March. This, with some of ones you received in Jan., will give you an idea of the volume of minutes coming in.

Your input will be added to the May 12 La State Docs Depository Advisory Council meeting discussion. WE NEED TO HEAR FROM YOU.

I suggest you do not process the minutes you receive in Jan, Feb & March until May when we make a decision on the number of copies. A decision will be made then on what to do about previous issues if we go to only 3 copies. Please call if you need clarification.
