**McNeese Theatre season postcards.** You need to keep the foldout 2005/6 one "Around the World with McNeese Theatre; an adventure from comedy to absurdity," control no. doc00536631. You can discard the individual postcards for each 2005/6 event because they are duplicates: Importance of Being Earnest; Butterfly; Crowns. I don't know why we did not get an individual one for Bald Soprano.

In 2003, we received a postcard for Tony Kushner's Perestroika 2003, EL 328.8p: MTS/Mar. 2003. It has a separate catalog record, control no. doc00514997. It might could be combined with the McNeese theatre season record, doc00536631, too, perhaps with a note listing each play title.

Same holds true for **La Tech Concert Assn season postcards.** You need to keep the 2005/2006 season card but the 4 individual event postcards for 2006 are duplicates since the exact information is on the season card.

The Dept of Agriculture mislabeled 3 issues of **Fruit & Vegetable Market News Service.** All are in the May MSL. Keep the copy with the correct issue no. Discard the copy with the incorrect issue no. You received both incorrect and correct issues by direct mail in May or May or the 1<sup>st</sup> few days of June.

*The Office of Lifelong Learning was not included in the 2001-2002 Executive Budget, being replaced as a budget item by a "Workforce Commission Office" (sic). The Louisiana Workforce Development Commission was created in the Governor's Office in 1997 (Act 1) effective April 1997, but funding for the commission does not show up in the Executive Budget until the FY 2001-2002 recommendations. I checked the resumes, acts, calendars, internet sources, etc., but can't find more precise documentation of the Office of Lifelong Learning's demise. My guess is it ended in 2001.]*

A 200.7: v/#/date **Louisiana Market Bulletin**. This note has been added to the State Library catalog record. Let's hope I got it right.

All 1999 issues are correctly labeled as v. 83.

2000 issues are correctly labeled v. 84 no. 1 through no. 15 (July 27, 2000);

the depository program did not receive an Aug. 10, 2000 no. 16 issue;

2000 issues no. 17 (Aug. 24) through no. 26 (Dec. 28) are all incorrectly labeled v. 83 instead of v.84.

All 2001 issues are correctly labeled v. 84 however

the Feb. 22 no. 4 is missing;

the April 19 issue no. 8 is incorrectly labeled no. 9;

the Sept. 6 no. 19 issue is incorrectly labeled no. 18 Aug. 23.

2002 v. 85 issues never rec'd: no. 1 (Jan 10), no. 6 (Mar 21), no. 13 (June 27), no. 16 (Aug 8).

Vol. 86, no. 24, Nov. 27, 2003 is incorrectly labeled no. 23.

In this May MSL, there is one entry for **Disaster Information Resources** from the LSU AgCenter, publication 2949 nos. A through J. There is a different entry for **There's a hurricane forming...**, prepared for the LSU Hurricane Center, LSU AgCenter, and Louisiana Sea Grant, by the Louisiana Geological Survey, Cartographic Section., but it is publication 2901. Your library may want to catalog the A – J items individually; heck, the State Library Tech Services Section may do that too when they upgrade our brief record to full MARC.

This month's shipment has a slew of **McNeese recruiting documents** published 2004 and 2005. I found it difficult to find a unique distinction among some. A 2000 or 2001 edition of some items had been submitted in those years to the depository program. When I could match the editions, I used the earlier LaDoc for the 2005 edition. Example: Invitation to annual Alumni Assn meeting; 2002 title: Join us and make a stand for MSU; 2005 title: Bigger roundup!

We got a document in 2002 and 2005 about the H. C. Drew Institute. The document covers only say McNeese State University. Inside the cover describes the Drew Institute. I changed the LaDoc to EL 300.2: MSUDI/date. The 2002 LaDoc, EL 300.2: MSU/date, is used for a few general documents about the university which usually only have McNeese State University as a title.

Most recruiting items carry the slogan "Excellence with a personal touch" on the cover. Occasionally, especially in the beginning, this may have been picked up as the title. I don't know the cataloging rule for this but, as you know, state agencies/institutions often put a slogan on their document covers. Some, like DOE, change it each year. The slogan does not refer to the content or actual title of the item. The problem with several of the

McNeese recruiting documents is that there is no title and the cover only says McNeese State University and the slogan. We tried to add dimensions and/or other characteristics to help distinguish items but it is a challenge. Please let us know if we have made errors or missed connecting some editions.

A survey of **core** state depository libraries showed that they did not need to receive each monthly issue of **Louisiana Register** mailed separately as soon as it is received in the Records Office. The La. Register will now be included in the regular monthly shipment for core libraries. Historical, selective and the special status depository libraries will continue to receive the Register in a separate mailing shortly after the 20<sup>th</sup> of each month.

At the May 12, 2006 meeting, the Advisory Council (LACSDDP) made the following decisions about **board/commission minutes**.

1. **Historical** depository libraries receive and archive only 1 copy of minutes.
2. **Law** depository libraries can select to receive minutes. The Recorder will work with the law libraries that want minutes to define a set of boards/commissions whose minutes will be distributed to them.
3. Other **Selective** depositories will not receive any minutes. The Special Status depository selected not to receive minutes.

For the **Selective** libraries that have minutes:

1. You can keep them in your collection if you want to but you will not receive any more issues.
2. You can discard all issues of the minutes. You do not need to list them in an offers list. You do not need to wait until Jan. 2007 to discard these minutes. However, you can choose to hold minutes until Jan. 2007 and put your discards on an offers list or just post a message on Bayoudoc that you are getting rid of board/commission minutes so the law library depositories can contact you for what they need.
3. **Law** libraries may directly contact selective depositories to try to acquire minutes being discarded.

At the end of this MSL notes is a 16-page list of the minutes received in depository program 2003-April/May 2006 and the explanation of the policy change and procedure to implement it.
