Board/commission minutes [a big confusion caused by me]

We sent semi-annual letters to many boards and commissions in Nov. 2004. Those that responded usually supplied the full number of copies of the minutes. It turned out to be LOTS of minutes even though we have not gotten minutes from all of the 260+ boards and commissions; some meet monthly.

The law says the Recorder of Documents can 'adjust' the number of copies required so in late Jan., I decided on only 3 copies for only distributed 3 copies for some of the boards/commissions. The 3 copies were distributed to State Library, LSU-BR and La Tech historical depositories to file/archive.

On Feb 7, I had 2<sup>nd</sup> thoughts so I polled several depositories that selected to get minutes from agencies, especially port/levee boards. I heard back from 4 of the 7: two law libraries wanted ports/levees and some others; 1 public library did not want any; 1 academic library could live without minutes but would like BESE minutes online [BESE only submits 2 or 3 copies].

I have held up the Jan MSL hoping to resolve this but decided I need more input from you. We are distributing all copies we receive in Feb. This, with some of ones you received in Jan., will give you an idea of the volume of minutes coming in.

**\*\*\* AFTER YOU RECEIVE THE FEB. SHIPMENT, LET ME KNOW IF YOU WANT TO CONTINUE TO GET BOARD/COMMISSION MINUTES.\*\*\*and which ones if it is only a few.**

*I suggest you do not process the minutes you receive in Jan & Feb until March when we make a decision on the number of copies. I will decide in March what to do about previous issues if we go to only 3 copies. Please call if you need clarification or have comments. I really want to hear from you on this.*

[La State Parks Plan 1997-2012 executive summary](#) (1997) is not an appendix.

Use CoP 1.1/3: date for [La Comprehensive Outdoor Recreation Plan](#), including parts that are Annual state action programs. Use CoP 1.1/3: date/A for [La State Parks Plan \(1973\)](#) if you want to make a distinction. Use CoP 1.1/3: date for [La State Parks Plan 1997-2012](#).

Most of these plans were originally assigned LaDoc CoP 1.1/3: date. The exceptions were:

Use this LaDoc for the bound volumes of the acts published many months after a session, 23 cm. You can use Y 1.1/1: yr/sess/vol. for "newspaper acts"]

1/06 from Paula Byars Dept. of Economic Development: Last year, we initiated a contract with LSU-Shreveport to begin compiling a woman- and minority-owned directory. So far, it has only those businesses which have registered at their website, but the list is growing, even though at this point it is so small as to not be of much use to someone who wanted a comprehensive list. The newest one came out last December. It is planned as an annual, but I believe they got behind schedule with all the excitement this past summer & fall. However, the DEC 2004 one is loaded on our website in 2 separate files, one for women, one for minorities. Louisiana Energy Topics is a supplement to Louisiana Energy Facts, NR 1.7/4: date. They have always had the same LaDoc number. If you want to, you can use NR 1.7/4: date/S for La Energy Topics. This leaves them filed together, as they are distributed.

The Advisory Council for the Early Identification of Hearing Impaired Infants authorizes many of the publications which are produced by the Dept. of Health and Hospitals, Office of Public Health, Hearing, Speech and Vision Services/Program. [I changed my mind on this several times; sorry if you do not agree.]
