I hereby apologize to absolutely everyone for accidentally deleting the lead letters on the Dec. MSL control numbers. To edit in the field names to the list, I do a global Find/Replace. In the Dec list, I forgot to replace the doc, sll or ocm... or else the Christmas Grinch stole all the 3-letter prefixes. You can take your choice of excuses.

In the Feb. 2007 shipment, 18 of you received a DVD titled GSMFC Reprint Library [a title invented for this disk]. This contains 21 different titles, including monographs and serials such as annual reports, minutes, and resolutions. We got 1 copy of 3 other CD/DVDs containing multiple titles but didn't distribute them. The agencies prepared these especially for the depository program, just simplifying things at their end by putting everything on one disk. We are trying to figure out how to catalog and classify these hybrid items so **there are no records yet** in the State Library catalog. We hope to have records for you in the April MSList.

The State Library cataloger is busy harvesting electronic-only (no tangible format) state documents then ingesting them into the Digital Archive (DA) of La state docs. [Doesn't this new lingo make you hungry?!] The catalog records have both the DA URL and the agency URL. Once a title is in the DA, we will stop printing out 1 paper copy. **We may even discard those single paper copies of the State Library historical depository because they are now permanently archived in electronic format in the DA.??**

The serial titles in the DA will be harvested on a schedule based on their frequency, e.g. daily to semiannual will be harvested twice a year, annual titles once a year. If we get more catalogers, the harvesting may be done more frequently but the catalog record has the agency URL at all times so you can get to the most recent issues there. The harvested issues will appear in a Monthly Shipping List the month of harvest.

If you keep statistics of the number of state docs received, do you count the e-only ones since you now have depository access to them? If you do, the number of *titles* will be less since the e-only ones will only appear in MSL once or twice a year. Right now, there are not too many e-only titles but there will be more all the time.

The Gulf States Marine Fisheries Commission delivered many boxes of documents in February, the result of a huge effort in their office to get their publications out into Louisiana depository libraries. Louisiana participates in the GSMFC. Almost all of these items had not ever been submitted. They sent as many paper copies as they had for each item. Some titles are serial but they were not able to supply every issue. Please do not claim missing issues because they simply are not available. Many items are fulltext on the GSMFC website; we tried to include that information on each catalog record.

Some items were published more than 6 years ago. ***I am making these an exception to the retention guidelines: for the GSMFC publications in the Feb & March 2007 shipments:

If your library does not need one of these GSMFC publications published before 2001, **you do not have to keep it, but**

YOU MUST OFFER IT ON BAYOUDOC. Do not simply discard one of these.

You do not have to get Recorder's permission to offer these GSMFC documents from the Feb & March 2007 shipments.

The information below is from the person who submits the Dept of Corrections Briefing Book. At our request, she added the title/cover sheet to the updates so you could tell what doc it is.

"... last quarter in an attempt to save paper on my end, I copied all of the pages of the Briefing Book front and back. In retrospect, I realized that this isn't the most efficient way because every page is not updated and removed each quarter. This quarter I have copied front and back the sections that will most certainly be updated each quarter and have made one-sided copies of the sections that might only be updated every fiscal year. Next quarter which will be complete some time in April I will make another set of complete copies of the Briefing Book for you to distribute.

I hope my explanation wasn't too confusing, and that this will make it a little easier for the librarians to have the most current and up to date information.

I could not find a LaDoc no. for 4-H; several docs about 4-H are under series AG 30.4/4. Right now, the only title under the new number, Ag 34 **4-H programs**, is minutes from the Grant Walker 4-H Educational Center.

Nicholls State University Policy & Procedure Manual Edition 2 Sept 2005 [Feb 2007 MSL] lists this history: Edition 1 of the Revised Format June 1993; Updated June 1994; Sept, 1995; Sept 1996; Sept 1997; Sept 1998; Sept 1999; Sept 2000; Sept 2001; Sept 2002; Sept 2003; Sept 2004.

It "combines and replaces the Faculty Handbook, Administration Handbook [EL 200.5: AS/date], and Civil Service Handbook—formerly known as "The Handbook System." This Manual was the result of collaboration between the former Clerk of the Handbooks, Assistant Vice President of Academic Affairs and SACS–COC Accreditation Liaison, and Coordinator of Policy and Procedure. Title XX Social Services Block Grant, Final Intended Use Report 2006/2007 is in this Feb. shipment. This title has a quite a history. Here is what I hope is an accurate (but not spellbinding) summary as it related to the LaDoc numbering.

- First appearance in Recorder's bibliography is OP VIII, **HW 40.8p:** yr for 1988/89 with the title: Final Intended Use Report: Title XX Social Services Block Grant, annual.

- All other appearances are in Monthly Shipping Lists & their PDs: 1996/97, 1999/00 – 2000/01, 2001/03 – 2005/06. These all use **HW 30.8p: BG/yr**. There has not been any note about a LaDoc number change in MSLs 2003-Jan 2007.

- State Library catalog has OCLC records that show this history of title changes in the records listed below. Notice that only the 4th has "intended use" in title:

1st Title XX comprehensive annual services program for the state of La [SLL doesn't own but this is a "preceded by" 780 field of # 2nd title; cataloged by Lib of Congress]

2nd Final title block grant comprehensive annual services bib 216095, 1988- . HW 40.8p:

3rd Final title XX block grant annual services program was -1988. bib 84001,

HW 40.8p:

4th Title XX social services block grant final intended use report was 1989- . bib 217302, HW 40.8p: as *current* 086, HW 30.8p: BG/ as *former* 086.

- The 2 other catalogs I checked, SELU and LaTech OPACs, use HW 30.8p: BG/yr for all their issues, 1996/97 – 2005/06.
- I can't find anything showing that a La. Recorder of Docs made this LaDoc change but the SLL OPAC record is assigning the 1st Recorder LaDoc HW 40.8p: , citing as "former" the LaDoc HW 30.8p: BG/ used from 1996/97 – 2006/07.*****

If you are with me this far, you have earned your state docs stripes! And you now know why the MSL has a LaDoc change in the notes table. I have listed the SLL catalog records here in case you want to use the 780 precedes and 785 preceded by fields. I hate to make LaDoc changes for serials because it causes you so much reclassifying effort. At least this time, you have the explanation of why I decided to make the change.
