District 08 Scoop newsletter from Dept. of Transportation and Development v. 8 no. 4 (Fall 2006) was distributed in this March shipment. The date and volume numbering are incorrect. The agency is sending correct replacement copies. They have asked that you discard the incorrect issue, please.

After all these years of ignoring the Louisiana State Personnel Manual [& Transmittal Sheet], CiS 1.5p: #, we have tried to improve the cataloging situation. The manual and transmittal sheets have always shared the same LaDoc no. but have separate catalog records, at least at the State Library. If you file/supersede the new pages in the manual, you may be saving the transmittal sheets as a record of the changes. Some of you may have given up on interfiling updates so you just file the transmittal sheets/update pages chronologically.

Transmittal sheets have always been listed under the title "State Personnel Manual Transmittal Sheet" in MSL/OP/PD beginning with OP III (no. 67-92, Dec. 20, 1957). The manual has only appeared twice in the Recorder's bibliographies: OP III has the manual listed (without date) although OP I has Personnel Rules of the Classified Service, 1943, 47p.; MSList May 2005 has 1 copy of 1994 manual which we had requested for the State Library.

In 5/2005, the agency told us that: the personnel manual is being slowly replaced by the Human Resources Handbook. The terms Personnel Manual and HR Manual/Handbook are used interchangeably. As portions of the manual are replaced, those sections will be added to the online Human Resources Handbook. At some point, the HR Handbook will completely replace the manual, but for the time being, both are used as a resource for the State's Human Resource Offices. As far as I know the last (complete) State Personnel Manual was issued in the 1990's and it has been updated over the years via transmittal sheets. These updates are available electronically.

Since 2005, we have put HR Handbook Updates on the personnel manual record.

The State Library Tech Srvs has made a record for the HR Handbook, Cis 1.5p1: #. It will contain Updates (2005-001 (Feb 17 2005) -) which were moved to this new record. We will use this new LaDoc no. from now on.

p.s. If your collection has the item below, you may change the LaDoc no. to avoid duplication with the State Personnel Manual/Transmittal Sheets number.

The Oct. Update, which should be in the April 2007 shipment, will be the **complete** Briefing Book but printed f/b. She will resend the full no. of copies of the Oct 2006 Update printed 1 side only; this will again be the **complete** Briefing Book.

We didn't get Oct & Jan 2007(Dec 2005) or March & July 2006 Updates. She will send 3 copies of these missed issues for historical depositories. *****When the non-historical depositories receive Oct 2006 & Jan 2007(Dec 2006), they can keep these 2 and discard everything prior to that and have a complete, current Briefing Book.*****

The March 2007 update will be out soon, expanded & looking different. Only the Public Safety & Corrections Secretary's office staff gets color copies; all graphics should be intelligible in black & white. Website has only current version of each section/page.

The rest of the older publications from the Gulf States Fisheries Marine Commission are in this shipment. Some of the 1980s titles were received and distributed to depository libraries in the 1980s. If we found the doc in the catalog of the State Lib and/or LSU-BR already, then we distributed only 1 more to them this month. We did not find these titles in other catalogs but you may have gotten them. **If any of these are duplicates for your collection, please offer them to others or send them back to the Records Office** with a note. We will get them back to the Commission.
