The LSU Paul M. Hebert Law Center did not produce an annual report for 2005/2006 or 2006/2007. In 2006/2007 they produced the LSU Law Magazine which the chancellor decided would serve as an annual report. There will probably be a 2007/2008 annual report but it will be web based only. Since there is a new chancellor, our liaison doesn't know when that publication will be produced.

The 2001 report Census of Fatal Occupational Injuries, is first to combine census and survey. Former titles: Census of Fatal Occupational Injuries Survey (L 1.1/4:date); Nonfatal Occupational Injuries and Illnesses (L 1.1/3:date). These two reports were published together as one document from the 1970s to the 1990s. The document number was L 1.1/3 (titled: Louisiana Occupational Injuries and Illnesses Survey).

This serial split into separate reports for nonfatal and fatal accidents. Both had the same document number: L 1.1/4 (titled: Census of Fatal Occupational Injuries, Louisiana, titled: Louisiana Nonfatal Occupational Injuries and Illnesses).

In 2004 the two reports reunited into a single publication. 2002 is last data year published by La Dept of Labor. However the La Dept of Labor maintains a link under <Labor Market Information, Miscellaneous, Census of Fatal Occupational Injuries> to the data on the U.S. Bureau of Labor Statistics site, Survey of Occupational Injuries and Illnesses.

This MSL contains some ephemeral documents that have been assigned a cataloger-supplied title and a consolidated LaDoc number. This is an attempt to minimize cataloging effort for ephemera. The individual item titles are listed in the MSL date field. In the catalog record, item titles are in 740 Additional title fields. All consolidated LaDoc numbers have a .4 stem and a standard cutter. Examples:
