# Gulf Coast Libraries Participate in Summit on Rebuilding

ibrarians and community - leaders from Gulf Coast coun-

ties and parishes that lost library buildings met in Baton Rouge, Louisiana, on November 28-30, to explore opportunities and share ideas for rebuilding. *Building Libraries, Building Community: A Summit on the Role of Public Libraries in Re-creating Community on the Gulf Coast* was hosted by the Southeastern Library Network (SOLINET) in partnership with the Mississippi Library Commission and the State Library of Louisiana.

Thirty-one public libraries were destroyed by the hurricanes in Louisiana and Mississippi. Many more remain closed or are operating with severe limitations.

This summit began a three-part rebuilding program for these public libraries. Following the Summit, libraries in these counties and parishes are now eligible for grants to assist in planning for new buildings. The Summit and planning grants are part of SOLINET's Gulf Coast Libraries Project, a three-year initiative funded by the Bill & Melinda Gates Foundation to support public libraries damaged by hurricanes in Louisiana and Mississippi. In addition to support for planning new buildings, the Gulf Coast Libraries Project will provide temporary libraries and book/tech mobiles, technology, materials, and staffing in communities that lost libraries.

"Libraries play an essential role in any community. In restoring our public libraries, we also begin the pains-taking process of restoring our communities," according to State Librarian Rebecca Hamilton of the State Library of Louisiana. Hamilton and several other SLOL staff attended the Summit.

Her statement is echoed in other counties and parishes. "Libraries add greatly to the quality of life and stability

of the communities," according to Cyndi Sellers, Library Board President in Cameron Parish, Louisiana.

"The purpose of the Summit was to provide a framework and context for planning library buildings and services in recovering Gulf Coast communities, recognizing that these libraries are assets to their communities and critical resources for positive, sustainable

community growth," according to Kate Nevins, Executive Director of SOLINET.

Community leaders and librarians in Louisiana attended from Calcasieu Parish, Cameron Parish, Jefferson Parish, New Orleans, Plaquemines Parish, St. Bernard Parish, St. Tammany Parish, Terrebonne Parish, Vermillon Parish and Washington Parish. Participants from Mississippi also represented Hancock County, Harrison County, Jackson-George Regional Library System and Long Beach Municipal Public Library.

Reports and recorded sessions from *Building Libraries*, *Building Community* will be available at SOLINET's Gulf Coast Libraries Recovery website in December.

# Viewpoint

has been a tough 18 months for the State of Louisiana. Extraordinary work has been done in extraordinary times, but even in the most difficult of circumstances, you have shown the world the importance of libraries. With the eyes of history upon us we proved our worth

When evacuees had very few options to obtain critical information, public libraries provided a safe haven, a compassionate heart and a "one stop shop" to get that urgent information. With homes destroyed, power down in much of the state, sporadic communications, yet a critical need to locate information, public libraries and library staff stepped up, went beyond the call of duty and served as front line responders to offer a hand to those most in need. I commend all of you for the tremendous things you did for your fellow Louisianans. Your work reminds me of a Tracy Chapman quote "I've seen and met angels wearing the disguise of ordinary people living ordinary lives."

With your help and input, the Office of the State Library implemented its strategic plan July 1, 2005. Hurricane Katrina struck in August. I had to stop us in our tracks and amidst the financial strain the state was experiencing, had to work hard to ensure that we kept our existing funding. With a total travel, hiring and spending freeze, and many vacancies, we struggled to serve all of our clients without diminished quality of service. In fact, from the very first day we were able to come back into the building that was the message I got from my staff. They vowed to do what it took to continue to serve.

With your help and the tremendous things you accomplished during and after the storms, you showed lawmakers the critical role libraries play, we were able to maintain our funding and now have the possibility of expanding our funding in FY 07-08. But still, we are just starting to recover. While we have been able to fill some vacancies, we still have many more to fill. Though the hurricanes did set our overall timetable back considerably, the State Library has been able to meet two primary concerns from directors. First, we were able to offer more technology assistance, such as E-rate and after hours service, and second, we were able to conduct more training workshops this fall.

In the coming months, my goals are to continue to fill vacant staff positions, to find a new ILL system, and for our staff to get out into the field for hands on assistance and to host more regional training sessions. We would also like to add to our databases. And of course, we are still in need of more state aid so that Louisiana can meet the national average.

While the hurricanes have long since passed, their repercussions have not. We are just now able to begin to put ourselves back together. I am confident that through all of our hard work and determination, our rebuilding efforts will continue to move forward. In adversity, we have shown our resilience. We have been able to adapt to horrific situations and work one step at a time to overcome and rebuild what we have lost.

### Calcasieu Parish Public Library Offers Free Digital Media to Cardholders

ardholders for Calcasie Parish Public Libraries can now enjoy the freedom to download titles to personal computers and supported portable devices. A collection of audio books, eBooks, music and video titles found at http://calcasieu.lib.overdrive.com can be downloaded to a computer and transferred to a portable device. Selected titles may be burned onto a CD.

According to CPPL Director Jeff Rippel, "With this step, the virtual library becomes real. The user doesn't have to leave the house or office to go to the library. The library goes to the user."

Calcasieu Parish Public Library purchased the service from OverDrive/Digital Library Reserve, Inc. Cardholders may check out three eBooks, audio books, music and videos on their own computers for 14 days.

Loretta Gharst, Computing and Collection Services Librarian, says, "This is an exciting opportunity for the Calcasieu Parish Public Library to expand the range of library services we offer and better meet the needs of busy patrons. Our Digital Library Collection gives our patrons 24/7 online access to eBooks, audio books, music and DVDs in the privacy of their own home and without the worry of materials becoming overdue. Another plus is that the library is able to expand our collection offerings without the space, handling and damage issues normally associated with audio and video media."

The new service can be enjoyed at home, at work or when traveling, but may not be downloaded on the computers in the library.



# Melissa Hymel Named Among 25 Winners of The New York Times 2006 Librarian Awards

he New York Times announced today the names of the 25 winners of the 2006 New York Times Librarian Awards. Melissa K. Hymel, Library Director of the Pointe Coupee Parish Library in New Roads, was among the winners. Now in its sixth year, the program honors librarians from around the country who have provided outstanding public service and have had a strong and positive impact on their nominators. This year's winners represent 17 states, including Arizona, California, Colorado, Connecticut, Georgia, Indiana, Louisiana, Massachusetts, Minnesota, New Jersey, New York, Ohio, Oklahoma, Pennsylvania, Tennessee, Texas and Washington.

"Thanks to the dedication of our exceptional librarians like Melissa Hymel, many of our libraries are back in business, serving the people of Louisiana," Lt. Governor Mitch Landrieu said.

"This is a tremendous honor for Melissa," according to State Librarian Rebecca Hamilton. "She and her staff have worked very hard to help both the local patrons of the Pointe Coupee Library system as well as those who needed so much help during the hurricanes. We are all extremely proud of Melissa."

Included among the 25 winners for the first time are three academic librarians. In an expansion of the program, librarians working in college and university libraries were eligible to be nominated by college students, faculty and administrators. Nominations for the public librarian awards came from the general public. The Times received more than 1,300 nominations from 45 states this year.

The Times held a ceremony and reception in honor of the winners on Dec. 13 at which each winner was given \$2,500 and a commemorative plaque from The Times. A separate plaque featuring the winner's name and title was sent to the library where each winner works. Gail Collins, editorial page editor for The Times, was guest speaker at the ceremony.

"We are very happy for this opportunity to celebrate librarians from across the country, whose enormous contributions sometimes go unrecognized," said Alyse Myers, senior vice president, chief marketing officer, The New York Times Media Group. "This year, we are also delighted to extend the Librarian Awards to academic librarians, who serve their college communities with the same devotion as the public librarians whose work we have hon-



ored since 2001. All librarians fill a vital role in our society – they are the people who bring together communities in the pursuit of knowledge. In doing so, they remind us that education and civic engagement are critical components of a thriving democracy. We applaud this year's winners and the work they do every day."

# Live Oak Library Reopens In Waggaman

Jefferson Parish Library announced that the Live Oak Library at 125 Acadia Drive, Waggaman, LA, was reopened November 20, 2006. The reopening ceremony and ribbon cutting held on December 5 featured local dignitaries and public recognition of gift donations to the library. Refreshments were provided by the Waggaman Civic Association.

Because of storm damage, the library had been closed since Katrina. The damage necessitated building the Live Oak children's collection back from scratch, which remains a work in process. Re-carpeting of the library has been completed and some furniture has been replaced. Though there are still improvements to be made, the Jefferson Parish Library administration felt that Live

Oak Library has been sufficiently revitalized to permit the return of valuable services to the Waggaman community without further delay, while the library continues to "build back better."

Visitors will immediately notice a customer-oriented interim layout and an expanded number of public access computers, more than double those available pre-Katrina. An exciting new feature is the addition of a DVD section. Soon, wireless Internet service will be added as well as other design improvements to enhance the user's experience.

# SLOL Hosts Fall Administrative Librarians Conference

he State Library of Louisiana hosted the Fall Administrative Librarians Conference on November 16 and 17 in Port Allen. The conference provided an opportunity for the state's library staff to network with other librarians and to create an action plan for their own libraries. Attended by the state's parish library administrators, the conference included several programs.

"Mission Possible: Sustaining Public Access Computing at Your Library" was a workshop on the Rural Library Sustainability Project, which is funded by a grant from the Bill & Melinda Gates Foundation. This particular program focused on sustaining public access computing and addressed challenges typically identified as obstacles to that goal. "Mission Possible" was a pilot for workshops that will be presented at various locations throughout the state at later dates, which will be on a smaller scale than the one at conference.

Attorney Greg Guidry, Chairman of Onebane Law Firm, also gave an extensive presentation on Labor and Personnel law, covering important information on effective employment practices as well as recent developments. he Federal-State Cooperative System (FSCS) for Public Library Data, a cooperative program of the National Center for Education Statistics (NCES) and the U.S. National Commission on Libraries and Information Science (NCLIS), presented the Kepel Award to Dorothy White, Senior Consultant of Library Development of the State Library of Louisiana.

have excelled in the completeness, promptness, and high quality of the local public library data that they collect, edit, and submit annually to NCES. The national public library data, including individual library data and State Library summaries, is made available by NCES from its web site <a href="http://nces.ed.gov/surveys/libraries/sla.html">http://nces.ed.gov/surveys/libraries/sla.html</a>. Summary tables are also published annually in hard copy under the title, *Public Libraries in the U.S*.

### East Baton Rouge Library Receives The Big Read Grant

he National Endowment for the Arts has awarded the East Baton Rouge Parish Library a \$20,000 grant for \*The Big Read: One Book/One Community program. The Library is one of

72 organization selected through a competitive grants process to receive funding which supports Big Read programs between January and June 2007. This grant will ensure that sufficient books and other materials are readily available throughout the nine parish area served by the Baton Rouge Area Chamber.

"With the Big Read we want to get everyone in a community - from high school kids and office workers to public officials and senior citizens - reading a great book together," said NEA Chairman Dana Gioia.

The Big Read: One Book/One Community program is sponsored by The Big Read, the East Baton Rouge Parish Library, and the Baton Rouge Area Chamber, who have partnered with libraries, school systems, religious and community organizations, and

key leaders of industry and commerce throughout the nine-parish area to implement this comprehensive program. The selected novel, *To Kill A Mockingbird*, was chosen for its wide appeal and social relevance.

Reading Discussion Groups will meet at libraries (including the State Library of Louisiana), bookstores, coffee shops and cafes, businesses, churches, schools, clubs, and homes over a concentrated period of time. Reading and Discussion Leaders are being trained to guide conversation on key themes of *To Kill A Mocking-hird* 

This program will extend over nine parishes: Ascension, East Feliciana, East Baton Rouge, Iberville, Livingston, Pointe Coupee, St. Helena, West Baton Rouge and West Feliciana, and will include public programs and lively discussions for a wide range of readers and interest, from middle school age students through retirees.

## Rapides Parish Library Wins \$100,000 Grant

he Rapides Parish Library's Preschool Outreach Plus is the recipient of a \$100,000 grant by Capital One Financial Corporation. "We had an exhaustive review of the number of people served and the effect it has on literacy," according to Wayne Denley, Central Louisiana area president for Capital One. "The library has such a good program. This should be a model for the rest of the country," he added. This grant will allow the library's program to expand its impact on small children as well as teach others to develop their own preschool outreach programs.

"Back in 1997, the staff at Rapides Parish Library in Alexandria began to realize that there had to be a better way

to improve literacy for very young children. The story times were poorly attended and not many children were being brought to the library. Clearly, something had to be done," said Steve Rogge, Library Director. "A commitment was made to build a strong outreach program that would reach preschoolers in Head Start and other child development centers."

Rapides Parish Library developed Preschool Outreach Plus, a unique outreach service that has been phenomenally successful. It began with serving 19 child development centers, and has grown to 64 centers as of July 2006. The program reaches about 3,000 students. More than 65,000 items were used by the centers in 2005.
