LaTrac data is derived directly from the General Ledger, and as such represents actual historical accounting data. The data on LaTrac is updated on a monthly basis with the most recent available complete month. The State Library will soon have a catalog entry for the web address with a link to the LaTrac but the database cannot be digitally archived.

LaMP Louisiana Mapping Project is not a state agency and their publications are not state docs. However, their publications on La flooding, etc. are very important to the vulnerable southern parishes. Beginning in Jan

2008, LaMP is releasing interactive Preliminary Digital Flood Insurance Rate Maps (DFIRMs). Two of the 4 LaMP videos concern the mapping project.

The project team for the Louisiana Mapping Project (LaMP) consists of FEMA Region VI, the FEMA New Orleans Transitional Recovery Office, Mitigation Division and Michael Baker Jr., Inc. (Baker). FEMA has engaged Baker, a nationally known engineering firm, to assist in the development and dissemination of information to the Louisiana coastal stakeholder communities. Baker has selected two local Louisiana firms, Digital Engineering & Imaging, Inc., headquartered in New Orleans and G.E.C., Inc., headquartered in Baton Rouge, along with Christopher P.
